OAA COMMUNITY SERVICE GUIDELINES

General Guidelines - Grades 9-12

1. A minimum of 25 hours per school year is required for a total of 100 by graduation (approved by the school board).
2. Service may be volunteered to the school and or the community.
3. Community Service hours accepted by our conference schools is transferable from school to school.
4. When performing Community Service for schools:
 - a. Students must perform volunteer service during non-school hours. (Exception: volunteer service may be performed during a school-wide Community Service Day.
 - b. Volunteer service must meet an identified school or community need.
 - c. Students may not receive a monetary or remunerative award for services. (i.e., Co-curricular activities that are a course requirement; participation in performances, festivals or competitions in which there is a charge for admission.)
 - d. Fundraising may count as community service if the funds raised are for the benefit of the school and or community.
5. When performing Community Service for the community:
 - a. Volunteer service must be for a non-profit organization and the participant cannot be paid.
 - b. Volunteer service must meet an identified community need.
 - c. Fundraising may count as Community Service if the funds raised are for the benefit of a school and or the community.

If a question exists about an activity for volunteer service, the Principal or the Registrar should approve the service prior to the student's participation.

Unacceptable Community Service

- Family related activities
- Jails, prisons and other detention facilities

- Service performed as a result of disciplinary action taken by the school or courts
